SWAN NEWS

Autumn 2020

Dear SWAN residents,

One impact of Covid was that we could only produce our last newsletter in digital format which you can still find on our website – <u>www.swancc.org.uk</u> Thankfully, we are now able to distribute them again door to door to let you know what is happening in the SWAN area.

During the pandemic it was not only the newsletter that was affected. Our office had to be closed to the public and a change of law allowed us to shift to virtual Council meetings. As a new Council, these restrictions were untimely but, like every other Council in the land, we supported the Government; putting public safety and the caring professions before our local communication needs.

Although our office is now open again by appointment, it is unlikely we will return to holding physical Council meetings for several months. However, the public may attend our virtual (Zoom) meetings but will need to contact the Clerk a minimum of one hour before the meeting start time.

At the height of the pandemic, a lot of excellent work was being undertaken by voluntary organisations working with Ashford Borough Council to support the community. We decided we would not try to replicate those support services and that it would be more beneficial to provide financial assistance to those organisations instead. In April 2020, we gave a maximum grant of £2000 to the Salvation Army to support its food preparation, distribution and drop-in service at their Cudworth Road premises.

One concern I have is the ongoing impact of the pandemic on small businesses in our area. In addition to the 'visible' businesses there are a significant number of micro-businesses and sole traders within the Borough. The need for the community to support local, small businesses has never been greater so, in this edition, we are highlighting our two pubs – The Alfred Arms and the Albion and the improvements they have made during the lockdown to entice you back.

We hope to continue this feature in the future and I hope you find the newsletter informative.

Parking and Traffic Survey - Facts, figures and results

We thank everyone who responded to our parking and traffic survey: Total responses - 239 Return rate - 11.5% 35 of 43 roads in the SWAN (81%) area covered Half of the residents who responded added additional comments/suggestions 15% of the responses were from households with disabled residents

Overall Results

54% felt that Parking is of greatest concern for residents **NOW**, followed by Safety. Pollution caused by increased traffic was considered least important.

When asked about the future, 51% felt that parking would still be the highest concern, but residents elevated pollution to equal second position with safety.

What are we doing with this information?

We alerted Ashford Borough Council to the findings when it considered the proposals for the Newtown Railway works, requesting an holistic, long-term, multi-agency review of traffic and parking issues in the area. Your survey responses supported the Planning Officer's proposals for a parking assessment in nearby streets, improvements to the Crowbridge Road bridge and some traffic calming initiatives on Newtown Road. They have also helped us to prepare our response to Ashford Borough Council on its draft cycling and walking strategy to 2030.

One of our key concerns is excessive overspill parking when the development is under construction and eventually completed. Councillor Gerry Clarkson, Leader of Ashford Borough Council, informed the Planning Committee that with sufficient parking spaces within the boundary of the development, there would be no negative impact on SWAN residents.

We have sent a copy to the Police with a request to increase enforcement for inconsiderate parkers who obstruct roads and footpaths. The dialogue with the Police will continue. A copy has also been sent to Kent County Council and we have started a discussion with them on Highways improvements. We have received quotations from Kent County Council on different types of speed indicator devices we might employ on their street light columns as an alternative or addition to the existing Speedwatch scheme which is managed by the Police.

As a Community Council we have limited highways and parking powers but we will, over time, consider residents' comments on a street by street basis to examine any opportunities to make improvements within the powers we have or to influence action by the Parking and Highways Authorities (Ashford Borough Council and Kent County Council respectively).

BT has made an application to remove several BT public phone boxes in Ashford, including the box on Newtown Green. From figures we have been given in 2019, 586 calls were made from that box which equates to around 2 per day on average. We would like to wish a warm welcome to all the children who have gone back to school this month! Kent County Council will be partnering with interested Parish, Community and Town Councils to install extra electric vehicle (EV) charge-points across Kent. The chargers will be located on land owned by the community, such as village hall car parks, and it is hoped that they can then be used by local residents and businesses that do not have off-street parking. The chargers will be owned and operated by KCC for public use. Any financial surplus generated by the charge points will be shared with the hosting council.

We have received feedback that some residents in the SWAN area are failing to be considerate when parking their vehicles. Please ensure that you park safely and keep in mind residents who are more vulnerable than others. Let's keep up the community spirit!

At a recent meeting, we spoke with Izzy about parking, speeding and drug crimes amongst other matters. She has given us information about frauds and scams which we feel you need to know about.

We'd like to highlight TV licence scams – phishing emails. If you are contacted and asked to pay for your TV licence using a different phone number, website or by posting your details to a different address then the one shown below, this is a scam.

TV Licensing, PO Box 578, Darlington DL98 1AN

TV Licensing will not come to your doorstep to collect the licence fee if you are over 75, so anyone who claims to do so is also a scammer!

There have been several reports of youths drinking and setting fire to shopping trolleys in the play area park by Bulleid Place and the recreation ground by Hamilton Road in the early hours of the morning. If anyone sees any fires, please call the Fire Service in the first instance. All the areas are being patrolled regularly to help deter these issues and for reassurance.

Car crimes – Keep your car locked. An unlocked vehicle parked on Herbert Roads has had money taken from inside . Report willful damage. A vehicle parked on Curtis Road has recently had its wing mirror pulled off.
