Members completed a previously circulated questionnaire regarding the portal and the challenges therewith.

44/22 To receive and consider comments from residents on access/parking issues in Riverbank Way, agree actions and recommendations to Council (Referred to P&H Cttee by Council – Minute 165/22)

Resolved: Proposed AH Seconded SC agreed unanimously 1) To do a street by street analysis within Clerk working hours with SC on bin collection day and another day 2) To investigate with Ashford Borough Council the risk assessment for the Euro Bins on Riverbank Way, can they be manoeuvred or do they have to remain in situ, to investigate what Operators can do to assist the situation, 3) to investigate if any central points for refuse collection can be arranged and how this would impact on Operators and on local residents to clarify if they would be able to move their own bins to this point. 4) To adjust the parking notice to highlight being mindful of the need for refuse vehicles to travel the area and the issues that are occurring and agree it by email. 5)To recommend to Council the purchase of waterproof compostable bags are bought to protect windscreen notices.

Action 1) SE and SC to complete street by street analysis 2) SE To investigate points 2,3,4 and refuse collection dates

3)All members to agree the adjustment to the parking notice by email.

45/22 To consider expanding the polite parking car windscreen notices to Kings Prospect (deferred from July 2022) and agree

Resolved: Proposed AR Seconded DM Agreed Unanimously to print 20 notices per Councillor and bring to Council at next meeting and arrange all available members to distribute on Kings Prospect once over a weekend and once the day before refuse collection. Dates to be set at Council. Action SE to print Parking Notices once agreed.

46/22 To update on the response from KCC motorcycle barriers and agree further actions for recommendation to Council

Members reviewed all correspondence to this item and had a lengthy discussion regarding the issues on residents and the investigations completed by PB with different mobility scooters and the issues that revealed. Members were also concerned on the impact on the local cycle network and were mindful of the need to question how any barriers to the cycle network in SWAN could be addressed.

Resolved Proposed SC Seconded PB and agreed unanimously 1) To contact KCC again and ask again for the costings of the barriers to be advised, 2) to check if the barriers are a national specification, 3) to query with the inter clerk forum similar measures in their areas and designs they have in place, 4) to contact the Bike App team to query if they approve of such barriers on the cycle network and consult Ani Chairing the Inter Clerks Forum who is working on this related project, 5) to request the design specification and measurements used on the barriers 6) To check the measurements, angles and tolerances applied and to ensure this is photographed and an evidence portfolio is gathered, 7) to renew endeavours to advertise for feedback from residents which were outstanding from the previous meeting

Actions Clerk and SC to complete items 1 and 2 and 5, 2) Clerk & AH to complete item 6) Clerk to complete all other actions and report to Committee.

47/22 To consider a verbal report from the Community Council Manager on outstanding actions for the Planning Committee.

SE gave a verbal report to advise of outstanding items since the last planning committee meeting. SE advised that due to the summer break the impact of the Queens death and staff sickness the

following items had not been progressed. 1) Advertising for resident impact evidence on the motorcycle nuisance barriers over the Summer break, 2) The Community Plan Objective to review the area from the point of view of disabled access had not been completed over the Summer months, 3) AH had not been invited to give a report on challenges on Planning and Highways from the Gladstone Road and Newtown area as requested as his Co-Option.

Resolved 1) As per item 46/22 this would be actioned over the next month, 2) To refer the issue to Council and ask if the objective should still be met by March and if any other members could assist if so or if the deadline needs to be moved. 3) AR requested AH to give his report and the following items were raised 1) Lorries much bigger than 7.5 tonnes are still traversing Newtown Road, daily cars are losing wing mirrors on Gladstone Road from vehicles too large delivering to local shops as well as further safety issues for drivers and pedestrians, That lorries had overturned into the gardens at the end of Newtown Road and this was a serious issue.

AR to review the items raised by AH, AH to consider the options to review the Highways Improvement Pack, PB an update on the motorcycle barriers be brought back.
