### IMPORTANT NOTES



- (b) where the DPI is not entered in the authority's register and is not the subject of a pending notification, but is disclosed at a meeting of the authority (or any committee, sub-committee, joint committee or joint sub-committee) as required by s31(2) of the Localism Act, before the end of 28 days beginning with the date of the disclosure at the meeting (s31(3) Localism Act 2011));**
- (c) where the DPI is not entered in the authority's register and is not the subject of a pending notification, before the end of 28 days beginning with the date when you become aware that you have a DPI in any matter to be dealt with, or being dealt with, by you acting alone in the course of discharging a function of the authority (s31(7) Localism Act 2011)).**

Failure to comply with these requirements would not be a criminal offence but would be a breach of the code of conduct.**
